ATHLETIC TRANSFER & NEW STUDENT INFORMATION

Welcome to Saucon Valley. As a new student/transfer athlete entering 7th-12th grade, a PIAA Athletic Transfer form must be completed to facilitate proper eligibility prior to your participation.

If you intend to participate in a school sponsored sport in the next 365 days, your PIAA Athletic Transfer Form must be completed and returned to the Athletic Office via our electronic submission form.

Information About Transferring Students and Transfer Rules:

Summer & Out of Season Transfers: Students transferring over the summer or transferring during the school year but outside the playing season should complete their PIAA Transfer Form as soon as possible after completing their registration for school. Summer transfer students who are Fall athletes must complete their transfer form prior to the start of PIAA practices beginning to ensure proper eligibility. Out of Season Transfers must complete their transfer form prior to participating in their first sport. Note: Students in 10th-12th grade may be subject to the PIAA's postseason ineligibility rules pending their transferring status.

In Season Transfers: Students transferring in the middle of the season in which they intend to play are subject to in season transfer rules. In-season transfer rules include a 21 days sit out period upon transfer in addition to any postseason ineligibility that may be applicable. It is advisable that completed PIAA Transfer Forms be completed and returned to the Athletic Office within 72 hours of enrollment at Saucon Valley if the athlete is an in-season transfer.

Transfer Paperwork Process:

Completion of the PIAA Transfer Form is required for participation in athletics. Please complete the following in a timely manner.

1. **[Complete the PIAA Transfer Form](#)**
 - a. Please complete Sections 2 & 3 fully, including a parent signature at the bottom of Section 3 before returning. The school will complete Section 1, 4, and all remaining information once received.
 - b. Note: When asked to document what sports the student participated in during grade 7 and beyond, list only school sponsored athletics.

2. **[Complete the Saucon Valley Transfer Information & Submission Form](#)**
 - a. Complete questions.
 - b. Upload your completed PIAA Transfer Form to the Submission Form

Transfer Ineligibility

In season transfer students are subject to a 21 days ineligibility period starting with their first day of enrollment at Saucon Valley.

Transfer students that have participated in school sponsored athletics in grades 10, 11, or 12 prior to their transfer are ineligible for postseason play during their first year unless a postseason waiver is granted. Information about a postseason waiver can be obtained by contacting the Athletic Office. If the athlete has participated in Athletics as a 10th, 11th, or 12th grader and you wish to request a postseason waiver you may complete this postseason waiver and attach it to the transfer submission form.
