LEHIGH VALLEY ACADEMY REGIONAL CHARTER SCHOOL

CHARTER ADDENDUM

Lehigh Valley Academy Regional Charter School (“Charter School”) and Saucon Valley School District (“SVSD”) hereby agrees to the following Addendum which is hereby incorporated into the December 7, 2021 Charter:

1. Subject to the conditions set forth in the December 13, 2021 Bethlehem Area School District (“BASD”) Charter between the Charter School and the BASD, if the Charter School enrolls any BASD student above the limits set forth within said Charter with BASD for which the Charter School has not been paid because of the limits, the Charter School will credit the same amount of tuition dollars to SVSD up to the total payment owed by SVSD to Charter School for SVSD students enrolled in the Charter School.
2. Notwithstanding the requirements of information and/or reports the December 7, 2021 Charter may be required to provide to SVSD, in addition, the Charter School shall make available upon request to SVSD any reports and/or information the BASD can require under the December 13, 2021 BASD Charter. A copy of the December 13, 2021 BASD Charter is attached as Exhibit 1.
